Annual Parish Meeting Minutes from January 27, 2013

I. Call to Order

The 2013 Annual Parish Meeting was called to order by Father Steven Mues, Rector, at noon in the Paris Hall. A quorum was present. Mike Ceramella was appointed clerk for the meeting. A booklet of the foll written reports was distributed to each person: Rector, Assistant Priest, Youth Ministries, Senior Warde Junior Warden, Treasurer (including the December 2012 Statement of Financial Position, December 201 Statement of Activities, December 2012 Dedicated Accounts and the proposed 2013 Budget), Acolytes, Guild, Daughters of the King (DOK), Men of St. Stephen's (MOSS), Music and Choir, Ushers, Worship Committee and Nominating Committee.

II. Minutes

Upon motion by Al Higdon and seconded by Joe Johnson, the minutes of the January 29, 2012 Annual P Meeting were approved.

III. Rector's Report by Fr. Steve Mues

- Fr. Steve distributed a handout with charts showing the Pledge, Plate & Non-Pledged Receipts fr 2005 through 2013 and the Average Sunday Attendance from 2004 to 2012. Last year, the avera Sunday attendance was one hundred forty-six (146) and the total was seven thousand five-hund and ninety (7,590) over the year. Attendance at Sunday services has increased over 80% in the p eight years from 4,184 in 2005 to 7,590 in 2012.
- Fr. Steve recalled the events of the 50th Anniversary Celebration on May 13' 2012 with the Rev. A • Mallonee, Vicar of Trinity, Wall Street, who had grown up at St. Stephen's, as our guest preacher Steve also recognized the participation as deacons by the Rev. Jeff Roper and the Rev. Bob Hirst. former rector Fr. Bob Layne and Fr. Sam Criss joined in the celebration. Special thanks were give Al Higdon for arranging paper and television coverage and to Mary Lynn and Frank Priest (and ot for assisting with arrangements.
- St. Stephen's has played a positive role at Larksfield by providing Chapel Service and Holy Comm • to about 15 residents there twice each month. Fr. Steve noted that this is a welcomed service w we uniquely provide.
- The Lay Eucharistic visitors made 125 visits in 2012 to10 members who are unable to attend church • service.
- Clergy made approximately 200 visits to hospitals and care facilities in 2012.
- The Rector's discretionary fund is received on the first Sunday of each month and given to people in need on a discretionary basis. Last year approximately \$4,000 in aid was distributed, and Fr. Steve attempted to use Dillon's Dollars and Gift Cards where we could.
- Fr. Steve noted that St Stephen's is among the largest in terms of individual contributors to Episcopal ٠ Social Services. Many St. Stephen's members are involved as volunteers as well as financial contributors.
- We had a generous response to our Christmas Outreach, which was conducted through the Wichita • Public Schools.
- St. Stephen's is active with the Kansas to Kenya outreach and one of our members, Diane Kruger, has made six trips to Kenya as part of the program.
- The new Informal Caring Network, comprised of participants from the Sunday 5:30 service, provided meals for a couple with health issues.

VII. Junior Warden's Report by Junior Warden Dale Graham

Dale thanked everyone for the successful Spring Fling church clean-up. He noted that an upcoming project will be to replace carpets in some of the public areas and thanked Felix Adams for agreeing to be his successor.

VIII. Treasurer's Report by Susie Stallings

The Treasurer's Report was presented by Susie Stallings. Susie noted that we ended 2012 \$1,300 "in the black" and that giving almost perfectly matched the pledges for which she was very appreciative. Although the proposed 2013 budget is currently showing a small shortfall of about \$10,000, she believes we will make this up during the course of the year, so this is not a worrisome amount. The proposed budget is on page 24 of the hand-out. Susie covered some smaller items: we can consolidate checks to the church and note different items in the memo line; if you turn in a receipt for a non-cash contribution, these will be noted in your giving statement; we were short flower money this year, so please consider combining with others for the weekly cost of \$60. Frank Priest will work on artificial flower arrangements to fill in on Sundays when there are no flower offerings.

Paul Attwater moved to accept the proposed budget and Leland Sinclair seconded. Motion carried.

IX. Other Matters

- There are now 13 acolytes.
- Rachel Bollinger expressed her appreciation to the volunteers for the choir and noted how Tom Grubb has really raised the bar for all involved in the music program and had built a music library. She encouraged teenagers to join the choir as the Wednesday night practices would not interfere with youth studies.

The St. Stephen's Choir consists of a small, but talented and dedicated group of volunteers who get together every Wednesday evening to rehearse; then don their purple robes on Sunday mornings, ready to lend their voices for the enhancement of our worship. We usually have a core group of about 6-8 singers. There are another 4 or 5 people we consider members of our ranks, but who have other responsibilities and activities which take precedence over choir participation. We're glad to have them sing with us when they can. Any others who might be interested in joining the choir are encouraged to give it a try. We would love to have you.

The choir mainly helps lead the congregational singing and usually prepares and sings a choral anthem at least once a month, most often as an offertory. Having a very limited number of singers, with no tenors, can be a bit of a challenge; particularly when it comes to finding music arranged in a manner which will fit the vocal resources available and also sound good. This has encouraged me to put my music composition and arranging skills to use. We have sung many unique anthems tailored to the specific needs of our choir. I always get a kick out of telling them we'll be presenting another world premiere. I'm going to go ahead and take this opportunity to single out Ben and Ashley Winters, who not only sing in the choir, but are very generous in working with the children's programs and doing solo work. When you hear them sing, there's no doubt they've had professional level voice training. We're very thankful to have them with us.

In reviewing the past year, two Sunday morning services stand out in my mind. We honored Mtr. Laurie on her last Sunday with us before embarking along a new path in her ministerial calling. She had been invited to pick some hymns which were especially meaningful to her. The choir sang a heartfelt rendition of one of my choral arrangements titled "A Parting Blessing." For Fr. Steve's last Sunday, we contracted the services of a professional trumpeter and sang celebratory hymns decked out with obbligato parts for the sopranos and trumpet. The choir sang a rousing version of "*I Bind Unto Myself Today*", a hymn which I know Fr. Steve loves. At the end of the service, we sang a lovely setting of "*Old Irish Blessing*," one of those songs which always seems to guarantee a welling-up of emotion.

In late October, I proposed we have a special service of Lessons and Carols on the first Sunday of Advent. Everyone seemed eager to lend their support and the choir and I immediately busied ourselves with the considerable task of getting all the music learned and rehearsed. All those involved put in extra time and effort to make this a success, and they were duly rewarded. I and others, I'm sure, found this to be a beautiful and meaningful way to begin the special season of Advent. We are also thankful for the other special services offered throughout the year which are such a blessing to us, especially on Christmas Eve and during Holy Week.

For Advent 3, the children were once again in fine form for their latest version of the Nativity Pageant which we always look forward to. I would like to find more opportunities for the young people to participate in collaboration with the choir. Send any ideas my way. In fact, I am always open to suggestions and like to get your feedback, both positive and negative.

As we begin a new chapter in the life of St. Stephen's Church, let us remember that there will always be much for us to learn and many new and interesting pathways to explore. I certainly feel this way about the vast world of music and worship. Peace to all in 2014 and remember to keep a Psalm in your Heart.



Dear Friends,

I am both optimistic and confident in the future of St. Stephen's church. St. Stephen's is now beginning to move from a very strong and healthy foundation into an exciting new era. Your church is sound financially with a good level of stewardship, spiritually healthy and blessed with good ministry programs and a positive relationship with our diocese and Bishop. Building and grounds have been improved significantly with many longer-term problems addressed (roof, painting, carpet, air conditioning/ heating and landscaping). There are a large number of new members and there are a healthy number of youth and children. CHILDREN & YOUTH MINISTRY

The Children's Ministry program has been full of excitement and quiet this last year. We provide formational opportunities for children nursery age through 5th grade on Sunday mornings. Averaging 104 people daily in St. Stephen's sharing God's love with each other. We added a mission component for the first time this year. We raised \$501 for the purchase of mosquito netting, which our Kansas to Kenya mission will deliver. Yes, I had to kiss a chicken in front of the whole parish on VBS Sunday, because they made their goal. It was a wonderful event for the children and adults.

The children are a part of the procession and process out to the Children's Chapel, where they hear the Gospel Reading, sing songs and pray. The Gospel is retold in words they can understand and discuss. The children return to their parents or the nursery at the "Peace". Attendance has been spotty, but overall consistent. Our great volunteers are Karen Norton, Susan Taylor, Leland Sinclair, D'Ambra Kruger and Nathan Williams. It couldn't be done without them.

When I consented to become your senior warden, knowing that Don and I were taking a ten-week trip to Alaska, I never dreamed that so much could happen in a year, but it did. And St. Stephen's not only survived, we thrived.

When Fr. Steve Mues decided it was time for him to retire, it also meant that Mtr. Laurie needed to find another position. We said good-bye to her in July, sending her off with a wonderful reception and nice going-away gift. In September, we bid adieu to Fr. Steve in a heartfelt going-away service, complete with presentations of pictures, a rousing rendition of My Favorite Things, and a tribute to Duck Dynasty! If one were to look back over the past eight years of Fr. Steve's tenure, we have indisputable evidence that our church is back to being a wonderful and vibrant institution.

Treasurer's Annual Report

OMG...which for me translates to Oh my goodness...what a year!

Anytime an organization, business, etc. experiences a major transition, be it change in staffing, physically moving, or even retirement announcements, there tends to be some anxious moments. Well, the finance office had a few anxious moments this year. The major concern for me all year was the fact that the 2013 budget was not balanced. The Vestry approved a negative \$10,000 bottom line, an amount I was comfortable with. A positive attitude allowed me to think "no big deal, we can overcome this." And then, as always, reality takes over. To make a long story short, as there are more enumerations than could ever be interesting to anyone other than me, we actually ended the year in a "not too bad" scenario.

Let me briefly explain. In February, Fr. Steve announced that he was going to retire in September. This announcement meant unbudgeted transition expenses would be incurred, \$\$\$. Also in February, the Jr. Warden, Felix Adams, was asked to complete numerous and necessary maintenance projects, \$\$\$. When the numerous and necessary projects were finished an additional \$11,000 of unbudgeted expense was added to the bottom line. In late spring, the Vestry decided it was time to comply with the insurance audit and replace the "rippled" carpet, \$\$\$. By then, all I could see were way too many dollar signs and the bottom line getting bigger and bigger. But by year end, the bottom line was only, with "only" being the good news, a negative \$15,000, -\$15,000 or (\$15,000) however you want to look at it. And that my friends is "not too bad"...considering.

The rippled carpet did get replaced. The narthex, great hall, all hallways, stairway and landing, the upper and lower level entry areas, the sacristy and parish offices all have new carpet. The carpet project reduced our capital by \$15,000, our project accounts i.e., garage sale, ice cream social, steak feed by \$16,000 and our operating income by \$1,100. This project was necessary; the church looks great, making all the work involved well worth the efforts.

The flower budget ended the year with only a \$300 deficit, much better than last year and my challenge to you this year is to make that a zero at the end of 2014. Your contributions to the coffee kitty of \$150 offset the fellowship expenses and your contributions to the memorial, sanctuary lamps and the lighted candles stands at the back of the church offset the Altar Guild expenses by \$350. I get excited over every dollar bill, dime, nickel, penny you are willing to give to the "cause", so keep the \$\$ coming my way.

The good news, as always, is because of you, the members of St. Stephen's. You continue to be the most loyal, faithful and giving people. We realized 98% of our pledges this year, and in addition, many of you gave beyond your pledge. The statistics support your loyalty year after year.

2014 looks promising as well. We received 77 pledges totaling \$260,205 making the total pledging unit \$3,379 per household. In addition to our pledging members, we also have a very loyal group of non-pledging members, representing a solid \$13,000 to \$15,000 of our income next year.

Our financial goals for next year are achievable. The Vestry is working toward consolidating our capital accounts, establishing a contingent account with a minimum of three (3) months operating expense, about \$60,000 to \$65,000. Once that is in place, the goal will be to grow the account to cover up to six (6) months operating expense. The work of establishing an Endowment Fund and a Planned Giving Program will continue in order to help secure our future.

My job is truly one of those where the value received far outweighs the gift. Thank you.
